

NOTICE OF NON-JUDICIAL FORECLOSURE SALE

WHEREAS, That certain Deed of Trust (the "Deed of Trust") dated April 2nd, 2024, from Nohe Villela Nunez ("Borrower"), as Grantor Carmen Majia, Trustee, filed for record on April 22nd, 2024 in Real Property Records of Gray County, Texas, more particularly described therein, which serves as security for a \$44,000 promissory note described therein (the "Note") executed by Borrower.

WHEREAS the undersigned has been appointed Substitute Trustee in the place of the said original Trustee, upon the contingency and in the manner authorized by the Deed of Trust; and

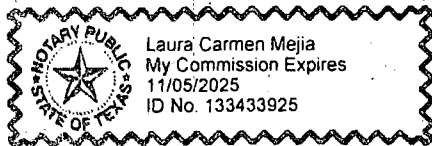
